ii. Playground maintenance

RB updated the Council that the basket swing had been fixed by Broadmead Leisure. RB presented the quote from Broadmead Leisure for both quarterly and bi-monthly checks on the playground. It was unanimously agreed to instruct Broadmead Leisure to carry out bi-monthly checks on the playground, RB to action.

RB updated the Council that Davis Bracey had undertaken the annual inspection of the playground - RB to share the report.

b) Larkshill

It had been suggested by KR that Larkshill may require a tidy-up before spring to help open up areas around the apple trees in particular. RB suggested sending around possible weekend dates at the end of February to see availability. Everyone agreed this was a good idea - RB to action.

c) Ware Charities

KN attended her first meeting in December representing the PC. She reported that it was a very interesting meeting and that the Charity has a lot going on! She shared her report from the meeting via email which included a report from Citizens Advice detailing the breakdown of support to residents in Thundridge, Ware and Wareside 2022-23. Other points to note are that the HSBC building is still yet to be sold. There is a buyer but some issues have arisen preventing the sale. The Charity has been given to Ware Food Bank to secure their premises at the priory for the next 5 years

d) Street Lighting

PG and RB are still working on this item, they believe they have a way forward but it is an issue that will take time to solve.

b) To finalise budget for FY 2024/25

RB presented the FY2024/25 and noted she had added in the bi-monthly playground checks by Broadmead Leisure as agreed early in the meeting. The PC agreed the budget was accurate.

c) PG noted that the PC projected expenditure for FY 2023/24 was inline with what was budgeted. Due to the increase in running costs and the need to fix an importantly placed street light the budget for FY 2024/25 has increased by almost £3000. It is also hoped that the red telephone box can be given some much needed tlc - £500 has been budgeted for this. In order to fund these much needed projects the Council acknowledged that the precept would need to be increased significantly compared to previous years - however the increase can be justified. MR proposed an increase of 25% taking the PC precept to

£12,996 - this would create a deficit of just under £500. Which could be covered by Council reserves. It was unanimously agreed to increase the precept by 25%.
